



## Farmington Community Civic Center Pool Rules & Policies

### General Policies

1. All guests shall behave in a manner as to avoid jeopardizing the health and safety of themselves and others. Disruptive behavior, including abusive or profane language is grounds for expulsion without refund.
2. Children 4 and under must be accompanied by a parent or guardian 16 years or older in the water
3. Children 5 to 11 years must be accompanied by a parent or guardian 16 or older
4. Entrance into the Civic Center indoor pool shall be refused to any person having a contagious disease or infectious conditions.
5. Anyone who has had diarrhea in the past two weeks shall not use the pool.
6. Anyone who has an area of exposed sub epidermal tissue, open blisters, cuts, etc., is advised not to enter the pools.
7. Appropriate swim attire is required in order to enter any of the pools in the water park. No cut offs, jean shorts, thongs. All clothing is subject to management review and discretion.
8. Inappropriate body marking such as offensive tattoos will be asked to be covered and are subject to review and discretion of management.
9. Flotation devices are prohibited with the exception of US Coast Guard Approved life vests. The water park has type II PFDs in various sizes available for guests up to 90 lbs. Infant/Toddler inflatable rings with seat are permitted as long as child is supervised by an adult. **Inflatable water wings and other inflatable rafts and rings are NOT permitted.**
10. Hanging on lap lanes and stainless steel railings is not permitted.
11. Glass containers are prohibited.
12. Swim Diapers are required on children 3 years or younger and those who are not toilet trained. Swim diapers are available for purchase at The Farmington Water Park front desk. Plastic or rubber pants are not permitted.
13. Horseplay and running on the pool deck are not permitted.
14. Breastfeeding area is available for the comfort and enjoyment for all guests in the guard room.
15. Pool management has the authority to implement and enforce rules that are more stringent to supplement those listed here for the safety of our guests.
16. Farmington Parks and Recreation reserves the right to refuse admittance into the Civic Center pool when the capacity of pool has been reached or when otherwise deemed necessary for the health, welfare or safety of its guests.

## **Slide Rules**

1. Riders must be 48" tall. Children may be required to be measured by staff to acquire a wrist band to ride the slides.
2. One (1) rider at a time.
3. Non swimmers are not permitted.
4. Life vests and other flotation devices are not permitted on the slide.
5. Wait until landing area is clear before entering the slide
6. Follow lifeguard's instructions
7. Rider must be in supine position on back when riding down slide.
8. Leave plunge pool immediately making sure not to cross the plunge area of the adjacent slide.
9. Foreign objects are prohibited in pockets. Jewelry cannot be worn while riding the slide. Exposed zippers, rivets or metal ornamentation are prohibited as they will scratch slide flume.
10. Riders must be in good health. Those suffering from heart disease, high blood pressure, epilepsy or on certain prescription medications should consult their physician.
