**REQUIREMENTS**

**General, Electrical, Plumbing, and Mechanical Contractors**

General Liability Insurance; a minimum of \$500,000 for personal injury and \$500,000 for property damage.
Effective January 1, 2012, all applications for a General Contractor, Electrical Contractor, Plumbing Contractor, or Mechanical Contractor must be accompanied by a testing certificate from the City of Farmington (or other approved communities) for the trade in which the license is granted.
<input type="checkbox"/> Commercial and Industrial Contractors, applying for a General, Electrical, Plumbing, or Mechanical Contractor License, must submit a code compliance bond of \$10,000. <input type="checkbox"/> Light Commercial and Residential Contractors, applying for a General, Electrical, Plumbing, or Mechanical Contractor License, must submit a code compliance bond of \$5,000.
All Contractors must submit proof of Worker's Compensation Insurance or complete a Waiver of Exemption.

**All Other Contractors**

Proof of liability insurance; a minimum of \$100,000 is required.
All Contractors must submit proof of Worker's Compensation Insurance or complete a Waiver of Exemption.
