City Council Minutes of Meeting August 14, 2014 6:30 p.m.

The City Council of the City of Farmington met on August 14, 2014, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: David Holman, Larry Forsythe, Lynn Crites, Darrel Holdman, Mark Kellogg, Garrett Boatright, and Denis Smith.

Councilman John Robinson was absent.

City Counselor, Scott Reid, was present.

Officials present were: Floyd Massey, Tim Barnes, Paula Cartee, and Larry Lacy.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Andrew Hammill addressed the Council suggesting that the City hire two additional African American police officers and one firefighter.

Chris Meyer, heating and cooling salesman, told the City that he would like to provide the equipment for the library.

Reports were given by Committee Chairs with Council discussion.

Councilman Forsythe made a motion to postpone Bill 64082014 until the August 25, 2014 meeting, seconded by Councilman Holdman, and passed unanimously.

BILL 64082014: AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF FARMINGTON, MISSOURI, TO ENTER INTO AND EXECUTE A CONTRACT WITH AMEREN MISSOURI. (AIRPORT POWER LINES)

Councilman Holdman made a motion to approve the consent agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Kellogg made a motion for the first reading by title only of Bill 65082014, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill once by title only.

BILL 65082014: AN ORDINANCE AMENDING THE GENERAL ZONING ORDINANCE AND ACCOMPANYING MAP THERETO AND KNOWN AS GENERAL ZONING ORDINANCE 11-2I BY CHANGING THE CLASSIFICATION OF THE ZONE DISTRICT FOR CERTAIN PARCELS OF LAND DESCRIBED HEREIN. (WEST PINE STREET)


Councilman Kellogg made a motion for the reading by title only and Council action on Resolution R10-2014, seconded by Councilman Smith, and passed unanimously.

RESOLUTION R10-2014: A RESOLUTION AUTHROZING AND DIRECTING THE MAYOR OF THE CITY OF FARMINGTON, MISSOURI, TO ENTER INTO AND EXECUTE A CONSENT TO ASSIGNMENT OF LEASE. (JASON HALE)

The Resolution passed unanimously.

Councilman Forsythe made a motion to adjourn, seconded by Councilman Crites, and passed unanimously.
