

# CITY OF FARMINGTON

## City Council Minutes of Meeting July 14, 2016 6:30 p.m.

The City Council of the City of Farmington met on July 14, 2016, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.
