

CITY OF FARMINGTON

City Council Minutes of Meeting December 18, 2017 6:30 p.m.

The City Council of the City of Farmington met on December 18, 2017, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Councilor Robinson gave the invocation.

The roll was called with the following Councilors present: John Crouch, John Robinson, Cody Eaves, Dale Wright, Mark Kellogg, Vanessa Pegram and Wayne Linnenbringer.

City Counselor, Scott Reid, was present.

Officials present were: Greg Beavers, Tim Porter, Larry Lacy, Michelle Daniel, Todd Mecey, Rick Baker, Chris Conway, Travis Trokey and Paula Cartee.

Councilor Robinson made a motion to approve the agenda, seconded by Councilor Kellogg, and passed unanimously.

Lana Wampler, 1814 Perrine Road, addressed the Council in opposition to the special deer hunt at Farmington Regional Airport.

Reports were given by Committee Chairs with discussion.

Greg Beavers, City Administrator, provided an update and answered questions from the Council.

After discussion, Councilor Eaves made a motion to approve the special deer (archery) hunt at Farmington Regional Airport, seconded by Councilor Crouch, and passed unanimously.

Councilor Crouch made a motion for the second reading by title only of Bill 67122017, seconded by Councilor Kellogg, and passed unanimously.

Counselor Reid read the following Bill once by title only.

BILL 67122017-ORDINANCE 15-11: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, MISSOURI: ESTABLISHING MINIMUM REGULATIONS GOVERNING THE DESIGN, CONSTRUCTION AND MAINTENANCE OF BUILDINGS, STRUCTURES, AND APPURTENANCES THERETO; TO ENSURE THAT THE PROPERTY, BUILDINGS, AND APPURTENANCES THERETO ARE SAFE, SANITARY AND FIT FOR OCCUPATION AND USE. Counselor Reid read the following Bill once by title only.

BILL 68122017-ORDINANCE 1-625: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, PROVIDING FOR THE ANNEXATION OF TERRITORY TO THE EXISTING CORPORATE BOUNDARIES OF THE CITY OF FARMINGTON, MISSOURI.
