An application for a Final Record Plat at Presbyterian Farms Subdivision (Case FRP-17-015). The property is currently zoned as "R-1", Single-Family Residential Zoning District. Submitted by Presbyterian Children's Home.

Tim Porter, Director of Development Services, explained the request and stated that Planning & Zoning gave a favorable recommendation.

Tim Porter, Director of Development Services, explained the request and stated that Planning & Zoning gave a favorable recommendation.


