City Council Minutes of Meeting August 9, 2018 6:30 p.m.

The City Council of the City of Farmington met on August 9, 2018, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Councilor John Robinson gave the invocation.

Councilor John Robinson made a motion to approve a liquor license to Aly Eck with The Alley Events LLC at 3 North Jefferson Street, seconded by Councilor Crouch, and passed unanimously.

Michelle Daniel, Finance Director, provided a financial overview.

Greg Beavers, City Administrator, provided an update and answered questions from the Council.


Councilor John Robinson made a motion for the first reading by title only of Bill 33082018, seconded by Councilor Crouch, and passed unanimously.

Counselor Reid read the following Bill once by title only.


