City Council Minutes of Meeting September 13, 2018 6:30 p.m.

The City Council of the City of Farmington met on September 13, 2018, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Councilor Crouch gave the invocation.


Councilor John Robinson made a motion for the first reading by title only of Bill 36092018, seconded by Councilor Linnenbringer, and passed unanimously.

Counselor Reid read the following Bill once by title only.


