City Council Minutes of Meeting December 13, 2018 6:30 p.m.

The City Council of the City of Farmington met on December 13, 2018, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Councilor Crouch gave the invocation.


