City Council Minutes of Meeting May 20, 2019 6:30 p.m.

The City Council of the City of Farmington met on May 20, 2019, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Forsythe.

Councilor John Robinson gave the invocation.


Councilor Joyce made a motion for the first reading by title only of Bill 16052019, seconded by Councilor Pegram, and passed unanimously.

BILL 16052019: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, APPROVING AN AMENDMENT TO THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, TITLE II: PUBLIC HEALTH SAFETY AND WELFARE, CHAPTER 210: ORDINANCE VIOLATIONS, BY ADDING A NEW SECTION REGULATING DISCHARGE FROM SUMP PUMPS AND ROOF DRAINS.

Councilor John Robinson made a motion to adjourn, seconded by Councilor Pegram, and passed unanimously.


