City Council Minutes of Meeting October 10, 2019 6:30 p.m.

The City Council of the City of Farmington met on October 10, 2019, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Forsythe.


Councilor Joyce made a motion for the first and second reading by title only of Bill 33102019, seconded by Councilor John Robinson, and passed unanimously.

Counselor Reid read the following Bill twice by title only.


