City Council Minutes of Meeting February 24, 2020 6:30 p.m.

The City Council of the City of Farmington met on February 24, 2020, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Forsythe.

Councilor John Robinson gave the invocation.

The roll was called with the following Councilors present: Edward Felker, John Robinson, Adam Parks, Dennis Robinson, Tom Joyce, Vanessa Pegram and Wayne Linnenbringer.

City Counselor, Scott Reid, was present.

Officials present were: Paula Cartee, Todd Mecey, Tim Porter, Larry Lacy, Rick Baker, Ashley Bischoff, Greg Beavers and Michelle Daniel.

Councilor John Robinson made a motion to approve the agenda, seconded by Councilor Pegram, and passed unanimously.

Debra Vallon, 9 Ava Court, addressed the Council regarding the lake in her yard and the reservoir that was promised in 2017 between Washington and Ava Court.

Kevin Berry, 22 Tanglewood, addressed the Council proposing a Baptizo Class that he would be willing to teach for the City of Farmington.

City Counselor, Scott Reid, stated that the City would not be able to sponsor a religious event, but Mr. Berry could rent the facility for his event if he wished.

Reports were given by Committee Chairs with discussion.

Councilor John Robinson made a motion to end the 3-way stop at Alexander & Maple, seconded by Councilor Pegram, and passed unanimously.

Greg Beavers, City Administrator, provided an update and answered questions from the Council.




Adjourn to Closed Session.
