The City Council of the City of Farmington met on May 26, 2020, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Pro-Tem, John Robinson.



Reconvene in Open Session.


Councilor Pegram made a motion to adjourn, seconded by Councilor Linnenbringer, and passed unanimously.
