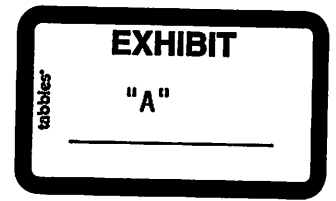


**VIOLATIONS BUREAU - OFFENSES AND FINES**

**NOTICE TO DEFENDANTS WHO BELIEVE THEY MAY BE INDIGENT:**

If you believe you may be indigent, you need to be aware of the following: court costs will not be assessed if a Defendant appears personally before the court and the court finds that the Defendant is indigent. Furthermore, if the court determines that a Defendant is indigent, the court will take such evidence into account in determining fines and establishing payment requirements.

The court has established procedures to allow Defendants who believe they are indigent to appear personally before the court and present evidence of their financial condition and, if the court determines that a Defendant is indigent, the court will not impose any court costs and will consider defendant's indigency in determining fines and establishing payment requirements.

**COSTS**

In accordance with state statutes and city ordinances, total court costs are \$28.50, which include: basic court costs \$12.00, Crime Victims Compensation Surcharge \$7.50, Law Enforcement Training Fund \$1.00, Peace Officer's Standard Training Fund \$2.00, Domestic Violence Shelter Surcharge \$1.00, Inmate Security Fund Surcharge \$2.00 and Sheriff's Retirement Fund Surcharge of \$3.00. Court costs shall be paid in addition to the fines for all matters set forth in this schedule.
